RULES & REGULATIONS:

Application Requirements

1. A submission of a signed application is a commitment to participate in the Winter Craft Market. Our Acceptance Letter is our commitment to have you exhibit. Artists who cannot do the show must cancel in writing. A full refund is available up until the deadline date of July 31, 2018. Acceptance Letters will be mailed on or before September 30th, 2019. There will be NO REFUNDS made after the acceptance letters have gone out.
2. Artists may apply in more than one category. If doing so, please treat each category as a separate application – sending in separate forms, checks, and photos. Exception: Jewelry as Adjunct. You may submit one application if selling jewelry as a secondary product.
3. Jewelry as Adjunct: Please indicate on your application if you plan to carry jewelry for sale as a secondary product, for example, a potter selling jewelry pendants. Only artists who have been accepted in this "jewelry as adjunct" category may display or sell jewelry.
4. Booth Rates: Current membership in the PA Guild of Craftsmen is required to qualify for the reduced booth fees. The PA Guild of Craftsmen Membership Directory will be used to determine who is qualified for the lower booth fee. To maintain membership status, you must pay your dues annually. To pay your State dues please go to the PA State Guild's website - www.pacrafts.org for an application form.
5. Booths: A limited number of double booths and corner booths are available. If the double booth request cannot be accommodated, the WCM committee will refund the artist if applicable.
6. Booth Sharing: Booth sharing by two artists is only permitted if their work is collaborative.
7. Booth Locations: All attempts are made to honor special requests, but locations are not guaranteed.

Submission Requirements

1. Image submission: Along with an application & payment, submission of five images is required. These 5 images must be submitted in one of the following forms:
 - 5 Photographs - (4 high-quality images showing the complete price range of your craft, 1 image of booth)
 - A labeled CD - (4 high-quality images showing the complete price range of your craft, 1 image of booth)
 - Digital images emailed to wintercraftmarket@gmail.com - (4 high-quality images showing the complete price range of your craft, 1 image of booth)

*If you are applying for jewelry as an adjunct you must include 4 additional photos of the jewelry.

These digital images will be retained by the WCM Committee and possibly used in our advertising campaign

2. Exhibitors may only display and sell the original work in the categories approved and accepted by the Committee. All the works offered for sale must be original works designed and executed by the artist. If work other than what has been approved is displayed for sale, the Committee has the right to ask for its removal.
3. The Artist whose name appears on the application must be present at the show. If the application is submitted by a team, both of the artists' names must be on the application & at least one of them present at the show at all times.

4. All work must be priced and for sale. Commercially produced merchandise, items assembled from commercially available parts or plans, kits, and items cast from commercial molds are not eligible for exhibit or sale. Final interpretation of commercial status will be made by the Winter Craft Market committee. No 'sale' or discounted priced items will be allowed- for example, no '20% off' signs, etc.

Booth Requirements

1. Exhibitors must supply all furnishings for their booth set-up to be contained within a 10x10 space, or 10x20 space in the case of a double booth. You must be able to adapt your booth to the sizes available at the event location.
2. A backdrop and sides are required. Draping, shutters, wood constructions are all potential backdrops. Anything that safely and aesthetically separates your booth from your neighbors is acceptable.
3. Lighting: Light fixtures may be used within the bounds of safety. Electrical hookup is available for an additional fee. Exhibitors must provide their own power strips and cords and these cannot be taped to the floor.
4. Tent Frames: EZ-UP or other tent frames may be used but no fabric tent tops are allowed. It is an easy adjustment to make to most tents and only requires a few hand tools.

Placement of exhibitors is at the discretion of the WCM Committee and their booth space may change at any time, even up until set-up night should problems with spacing arise.

Submit application, images and check for total booth costs, payable to WINTER CRAFT MARKET

If not accepted, check will be destroyed.
